# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0755

Affirmed
Ineligible Weeks 22-20 through 26-20 and 32-20 through 35-20

**PROCEDURAL HISTORY:** On December 28, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work during the weeks including May 24, 2020 through August 29, 2020 (weeks 22-20 through 35-20) and therefore was ineligible to receive unemployment insurance benefits for those weeks (decision # 92915). Claimant filed a timely request for hearing. On June 6, 2022, ALJ L. Lee conducted a hearing at which the employer failed to appear, and on June 14, 2022 issued Order No. 22-UI-196036, modifying decision # 92915 by concluding that claimant was not available for work during the weeks including May 24, 2020 through June 27, 2020 (weeks 22-20 through 26-20) and August 2, 2020 through August 29, 2020 (weeks 32-20 through 35-20) and therefore was ineligible to receive benefits for those weeks. On July 5, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB did not consider claimant's written argument when reaching this decision because she did not include a statement declaring that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-196036 is affirmed.

However, as the order under review concluded that claimant was ineligible to receive benefits for different weeks than those found in decision # 92915, the order *modified* the administrative decision.
