EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0756

Late Application for Review Dismissed

PROCEDURAL HISTORY: On March 19, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that wages and hours of work claimant requested could not be added to his claim because no wages were submitted by the claimant or business. On March 29, 2021, the administrative decision dated March 19, 2021 became final without claimant having filed a request for hearing. On April 14, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on February 8, 2022 issued Order No. 22-UI-185882, dismissing the request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 22, 2022. On February 18, 2022, claimant filed a timely response to the appellant questionnaire. On May 19, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for June 3, 2022 to determine whether claimant's late request for hearing should be allowed and if so, the merits of the March 19, 2021 administrative decision. On May 31, 2022, the Department served notice of an administrative decision moving wages claimant was paid from the employer from the wrong quarter to the correct quarter in claimant's base year. On June 3, 2022, ALJ Janzen conducted a hearing at which the employer did not appear, and on June 10, 2022 issued Order No. 22-UI-195903, allowing claimant's late request for hearing on the March 19, 2021 administrative decision and modifying that decision, as set forth in the May 31, 2022 decision. On June 30, 2022, Order No. 22-UI-195903 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On July 6, 2022, the employer filed a late application for review of Order No. 22-UI-195903 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement submitted with the employer's application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: Order No. No. 22-UI-195903, mailed to the employer on June 10, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. No. 22-UI-195903 at 5. Order No. No. 22-UI-195903 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before June 30, 2022 to be timely."

CONCLUSIONS AND REASONS: The employer's late application for review of Order No. No. 22-UI-195903 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. No. 22-UI-195903 was due June 30, 2022. Because the employer did not file their application for review until July 6, 2022, the application for review was late. The employer provided a written statement with the application for review. However, the employer's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, the employer did not show good cause for the late application for review, and their late application for review is dismissed.

DECISION: The application for review filed July 5, 2022 is dismissed. Order No. 22-UI-195903 remains undisturbed.
