EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0766

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 7, 2021 the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective December 6, 2020. On July 27, 2021, the July 7 2021 PUA determination became final without claimant having filed a request for hearing. On December 3, 2021 claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on March 8, 2022, issued Order No. 22-UI-188055, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 22, 2022. Claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response, and on June 16, 2022 issued Order No. 22-UI-196329 re-dismissing claimant's request for hearing as late without good cause, leaving the PUA determination undisturbed. On July 6, 2022, Order No. 22-UI-196329 became final. On July 7, 2022, claimant filed a late application for review of Order No. 22-UI-196329 with the Employment Appeals Board EAB.

FINDING OF FACT: Order No. 22-UI-196329, mailed to claimant on June 16, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-196329 at 3. Order No. 22-UI-196329 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 6, 2022 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-196329 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it

includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-196329 was due July 6, 2022. Because claimant did not file his application for review until July 7, 2022, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented him from filing the application for review by the July 6, 2022 deadline. Accordingly, claimant did not show good cause for the late application for review, and his late application for review is dismissed.

DECISION: The application for review filed July 7, 2022 is dismissed. Order No. 22-UI-196329 remains undisturbed.
