EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0767

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 14, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which they were not entitled, and assessing an overpayment of \$1,800 in Lost Wages Assistance (LWA) benefits that claimant was required to repay to the Department (decision # 0563689). On January 3, 2022, decision # 0563689 became final without claimant having filed a request for hearing. On March 14, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on June 15, 2022 issued Order No. 22-UI-196180, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 29, 2022. On July 5, 2022, Order No. 22-UI-196180 became final without claimant having filed a response to the appellant questionnaire with the Office of Administrative Hearings (OAH) or an application for review with the Employment Appeals Board (EAB). On July 7, 2022, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 22-UI-196180 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's July 7, 2022 response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 22-UI-196180, mailed to claimant on June 15, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-196180 at 2. Order No. 22-UI-196180 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than July 5, 2022."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-196180 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-196180 was due by July 5, 2022. Because claimant did not file their application for review until July 7, 2022, the application for review was late. Claimant's appellant questionnaire response, submitted with the application for review on July 7, 2022, included a fax "transmission verification report" showing that claimant unsuccessfully attempted to fax the appellant questionnaire response on June 30, 2022 to the fax number listed on the appellant questionnaire. EAB Exhibit 1 at 2, 4. However, the appellant questionnaire would still have been late on June 30, 2022, and in any case claimant did not explain either why they did not attempt to fax the response a second time, or else why they did not attempt to submit the response by another means. Further, claimant did not show that they otherwise attempted to file an application for review on or prior to July 5, 2022.

In their appellant questionnaire response, claimant indicated that they filed the late request for hearing on decision #0563689 because "due to [their] medical condition [they] get foggy due to [their] treatment." EAB Exhibit 1 at 2. Claimant further explained that they "felt because [they are] high risk with a disability that [they] needed more time to process the decision." EAB Exhibit 1 at 2. Claimant's response suggests that they might have filed the late request for hearing on decision #0563689 due to a medical condition that constituted a factor beyond their reasonable control. However, claimant did not suggest that this same factor caused them to file the application for review of Order No. 22-UI-196180 after the filing deadline, several months after they filed the late request for hearing on decision #0563689. In fact, claimant did not offer any description of the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and their late application for review is dismissed.

DECISION: The application for review filed July 7, 2022 is dismissed. Order No. 22-UI-196180 remains undisturbed.
