EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0770

Affirmed Ineligible

PROCEDURAL HISTORY: On May 16, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from April 17, 2022 through May 7, 2022 (weeks 16-22 through 18-22) and was therefore not eligible to receive unemployment insurance benefits for those weeks (decision # 120710). Claimant filed a timely request for hearing. On June 28, 2022, ALJ Mott conducted a hearing, and on June 29, 2022 issued Order No. 22-UI-197164, affirming decision # 120710. On July 8, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision. In it, claimant argued that she should not have been considered outside her normal labor market area and therefore should have been deemed available for work. More specifically, claimant, who lived in Portland, Oregon, asserted that her normal labor market area should not have been defined as the Portland and Vancouver, Washington metropolitan areas, as the Department witness testified to at hearing, and which Order No. 22-UI-197164 listed as a finding of fact. *See* Transcript at 7; Order No. 22-UI-197164 at 1. Claimant contended that because the work she sought was remote work, her normal labor market area should have been defined as any location in the United States, and she therefore should not have been treated as unavailable for work for spending the major portions of the period of April 17, 2022 through May 7, 2022 outside the Portland and Vancouver metropolitan areas.

However, OAR 471-030-0036(6)(a) (March 25, 2022) defines an individual's normal labor market as "the geographic area surrounding the individual's permanent residence within which employees in similar circumstances are generally willing to commute to seek and accept the same type of work at a comparable wage." The administrative rule specifically tasks "employees of the Employment Department" with defining the geographic area. The Department's determination that claimant's normal labor market area was the Portland and Vancouver metropolitan areas was reasonable given that claimant permanently resided in Portland. Although the work claimant sought during the period of April 17, 2022 through May 7, 2022 was remote in nature, the rule speaks of the geographic area similarly situated employees are willing to "commute"—not telecommute, telework, or work from home. The language of the rule contemplates that the geographic area the Department is tasked with defining be

limited in scope to some reasonable, traditionally commutable distance from the individual's home. Thus, claimant's argument that her normal labor market area should have been viewed as geographically boundless and, as a result, that she should have been viewed as available for work during the period of April 17, 2022 through May 7, 2022, is without merit.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-197164 is affirmed.
