# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0778

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On February 22, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. Claimant filed a timely request for hearing. On April 7, 2021, ALJ Scott conducted a hearing, and on April 9, 2021 served Order No. 21-UI-164477, affirming the February 22, 2021 administrative decision by concluding that claimant was not entitled to receive PUA benefits for the weeks including March 22, 2020 through April 3, 2021 (weeks 13-20 through 13-21). On April 29, 2021, Order No. 21-UI-164477 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 12, 2022, claimant filed a late application for review of Order No. 21-UI-164477 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**FINDING OF FACT:** (1) Order No. 21-UI-164477, mailed to claimant on April 9, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-164477 at 4. Order No. 21-UI-164477 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before April 29, 2021 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-164477 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-164477 was due by April 29, 2021. Because claimant did not file their application for review until July 12, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed July 12, 2022 is dismissed. Order No. 21-UI-164477 remains undisturbed.
