

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0784

Late Application for Review Dismissed

PROCEDURAL HISTORY: On November 12, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective September 5, 2021 (decision # 142722). On December 2, 2021, decision # 142722 became final without claimant having filed a request for hearing.

On January 13, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 11, 2022 issued Order No. 22-UI-191016, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 25, 2022. On May 2, 2022, Order No. 22-UI-191016 became final without claimant having responded to the appellant questionnaire or filed an application for review of Order No. 22-UI-191016 with the Employment Appeals Board (EAB). On May 26, 2022, claimant filed a late response to the appellant questionnaire. On June 9, 2022, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. On July 12, 2022, claimant file a late application for review of Order No. 22-UI-191016 with EAB.

FINDING OF FACT: (1) Order No. 22-UI-191016, mailed to claimant on April 11, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-191016 at 2. Order No. 22-UI-191016 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than May 2, 2022."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-191016 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-

041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-191016 was due by May 2, 2022. Because claimant did not file their application for review until July 12, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant’s written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed July 12, 2022 is dismissed. Order No. 22-UI-191016 remains undisturbed.
