# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0786

Late Application for Review Dismissed

PROCEDURAL HISTORY: On June 25, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant file late claims for unemployment insurance benefits for the weeks including May 16, 2021 through June 5, 2021 (weeks 20-21 through 22-21) and therefore was ineligible to receive benefits for those weeks (decision # 104007). On July 15, 2021, decision # 104007 became final without claimant having filed a request for hearing. On September 29, 2021, claimant filed a late request for hearing on decision # 104007. ALJ Kangas considered claimant's request, and on December 1, 2021 issued Order No. 21-UI-180835, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 15, 2021. On December 10, 2021, claimant filed a timely response to the appellant questionnaire. On March 2, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 21-UI-180835 was vacated and that a new hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of decision # 104007.

On March 18, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for March 30, 2022 at 10:45 a.m. On March 30, 2022, claimant failed to appear at the hearing, and ALJ Ramey issued Order No. 22-UI-190052, dismissing claimant's request for hearing for failing to appear. On April 4, 2022 and April 18, 2022, claimant filed timely requests to reopen the March 30, 2022 hearing. On June 7, 2022, ALJ Lucas conducted a hearing, and on June 14, 2022, issued Order No. 22-UI-196101, concluding that claimant had good cause to reopen the March 30, 2022 hearing and to file the late request for hearing on decision # 104007, and affirming decision # 104007 on the merits. On July 5, 2022, Order No. 22-UI-196101 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 13, 2022, claimant filed a late application for review of Order No. 22-UI-196101 with EAB.

**FINDING OF FACT:** (1) Order No. 22-UI-196101, mailed to claimant on June 16, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-196101 at 6. Order No. 22-UI-196101 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 5, 2022 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. Order No. 22-UI-196101 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-196101 was due by July 5, 2022. Because claimant did not file their application for review until July 13, 2022, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented them from filing the application for review by the July 5, 2022 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed July 13, 2022 is dismissed. Order No. 22-UI-196101 remains undisturbed.
