EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0789

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 28, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was disqualified from receiving unemployment insurance benefits effective December 12, 2021 (decision # 90856). Claimant filed a timely request for hearing. On June 14, 2022, ALJ Demarest conducted a hearing at which the employer failed to appear, and on June 15, 2022 issued Order No. 22-UI-196157, reversing decision # 90856 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On July 5, 2022, Order No. 22-UI-196157 became final without the employer having filed an application for review. On July 13, 2022, the employer filed an application for review with the Employment Appeals Board (EAB).¹

FINDING OF FACT: (1) Order No. 22-UI-196157, mailed to the employer on June 15, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-196157 at 2. Order No. 22-UI-196157 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 5, 2022 to be timely."

CONCLUSIONS AND REASONS: The employer's late application for review of Order No. 22-UI-196157 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or

¹ The filing date of the application for review was July 13, 2022 because that was the date of the postmark affixed to the envelope of the application for review. *See* OAR 471-041-0065(1)(b) (May 13, 2019). Per OAR 471-041-0060(5) (May 13, 2019), the employer's application for review was treated as an application for review rather than as a request to reopen the June 14, 2022 hearing because, although the employer did not appear at the hearing, they did not include a written statement with their application for review setting forth the reason(s) for missing the hearing as required under OAR 471-040-0040(3) (February 10, 2012).

circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-196157 was due by July 5, 2022. Because the employer did not file their application for review until July 13, 2022, the application for review was late. The employer's application for review did not include a written statement describing the circumstances that prevented the employer from filing the application for review by the July 5, 2022 deadline. Accordingly, the employer did not show good cause for the late application for review, and the employer's late application for review is dismissed.

DECISION: The application for review filed July 13, 2022 is dismissed. Order No. 22-UI-196157 remains undisturbed
