

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0801**

*Affirmed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On January 14, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective November 15, 2020 (decision # 85756). Claimant filed a timely request for hearing. On February 9, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing on decision # 85756 scheduled for February 22, 2021 at 10:45 a.m. On February 22, 2021, claimant failed to appear at the hearing, and on February 23, 2021, ALJ Wyatt issued Order No. 21-UI-161459, dismissing claimant's request for hearing on decision # 85756 due to claimant's failure to appear. On March 5, 2021, claimant filed a request to reopen the hearing. OAH considered the request, and on June 24, 2021 mailed a letter stating that Order 21-UI-161459 was vacated and that a hearing would be scheduled to address the timeliness of claimant's hearing request and, if appropriate, the merits of decision # 85756.<sup>1</sup>

On June 15, 2022, OAH served notice of a hearing scheduled for July 6, 2022 on whether claimant's request to reopen should be allowed, and if so, the merits of decision # 85756. On July 6, 2022, ALJ Logan conducted the hearing, and on July 14, 2022 issued Order No. 22-UI-198263, allowing claimant's request to reopen and reversing decision # 85756 by concluding that claimant was discharged, but not for misconduct, and that claimant was therefore not disqualified from receiving benefits based on the work separation. On July 18, 2022, the employer filed an application for review of Order No. 22-UI-198263 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-198263 is affirmed.
