

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0809**

*Late Application for Review Allowed*  
*Affirmed ~ Disqualification*

**PROCEDURAL HISTORY:** On July 30, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer with good cause and was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 83050). The employer filed a timely request for hearing. On June 27, 2022, ALJ Davis conducted a hearing and issued Order No. 22-UI-196932, reversing decision # 83050 by concluding that claimant quit without good cause and was disqualified from receiving benefits effective April 4, 2021. On July 18, 2022, Order No. 22-UI-196932 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 19, 2022, claimant filed a late application for review of Order No. 22-UI-196932 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the statement claimant included with her application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**WRITTEN ARGUMENT:** Because claimant's August 19, 2022 argument on the merits of Order No. 22-UI-196932 was not received by EAB within the time period allowed under OAR 471-041-0080(1) (May 13, 2019), the argument was not considered by EAB when reaching this decision. OAR 471-041-0080(2)(b).

**FINDING OF FACT:** (1) Order No. 22-UI-196932, mailed to claimant on June 27, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-196932 at 3.

Order No. 22-UI-196932 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before July 18, 2022 to be timely.”

**CONCLUSIONS AND REASONS:** Claimant’s late application for review of Order No. 22-UI-196932 is allowed. Order No. 22-UI-196932 is affirmed. Claimant quit working for the employer without good cause is disqualified from receiving benefits effective April 4, 2021.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-196932 was due by July 18, 2022. Because claimant did not file their application for review until July 19, 2022, the application for review was late. In the statement included with claimant’s application for review, she explained that she was “very ill” with COVID-19 at the time she received Order No. 22-UI-196932 and was unable to “make any statements or decisions” until she recovered from the illness on August 6, 2022. EAB Exhibit 1 at 1. Claimant presumably *was* able to make statements or decisions prior to August 6, 2022, as she filed her application for review prior to that date. Nevertheless, it is reasonable to infer from claimant’s statement that she was too ill to file the application for review until after the timely filing deadline had passed. Claimant therefore filed the late application for review due to circumstances beyond her reasonable control. And because claimant filed her application for review only one day after the deadline passed, she did so within seven days after the circumstances that prevented a timely filing ceased to exist, and therefore within a reasonable time. Claimant’s late application for review therefore is allowed.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Claimant’s late application for review is allowed. Order No. 22-UI-196932 is affirmed.
