

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0820

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On April 11, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which she was not entitled, and assessing an overpayment of \$3,900 in Federal Pandemic Unemployment Compensation (FPUC) benefits and \$1,722 in Pandemic Emergency Unemployment Compensation (PEUC) benefits that claimant was required to repay to the Department via offset against future benefits (decision # 103347). Claimant filed a timely request for hearing. On July 10, 2022, claimant submitted correspondence that the Office of Administrative Hearings (OAH) construed as a request to withdraw the request for hearing on decision # 103347. On July 20, 2022, ALJ Meerdink issued Order No. 22-UI-198671, dismissing claimant's request for hearing on decision # 103347. On July 25, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's July 10, 2022 email to the Department, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

CONCLUSIONS AND REASONS: Order No. 22-UI-198671 is set aside and this matter remanded for a hearing on whether claimant intended to withdraw their hearing request on decision # 103347, if not, the merits of that decision.

Under ORS 657.270(7)(a) and OAR 471-040-0035(1) (August 1, 2004), an administrative law judge may order that a request for hearing be dismissed if the request has been withdrawn by the party who filed the request. On July 10, 2022, claimant sent an email to the Department stating, "Wanted to write you once more, I don't need an appeal I just wanted to backdate my claim, thank you." EAB Exhibit 1.

OAH construed this email to mean that claimant wished to withdraw their request for hearing on decision # 103347, and dismissed claimant's request for hearing on that basis. However, claimant did not clearly state that she wished to withdraw her hearing request, and it is possible that she did not understand that stating that she did not "need an appeal" would be construed to deny her a hearing on the merits of decision # 103347 and the relief she was seeking when she stated "I just wanted to backdate my claim." This ambiguity, coupled with the fact that claimant continued with the appeals process when she filed the application for review on Order No. 22-UI-198671, suggests that she may not have intended to withdraw the request for hearing.

On remand, the ALJ should ask claimant what she meant in her July 10, 2022 email in order to determine whether claimant actually intended to withdraw the hearing request. If the record on remand shows that claimant did not intend to withdraw the hearing request, the ALJ should proceed to hearing the merits of decision # 103347.

DECISION: Order No. 22-UI-198671 is set aside, and this matter remanded for further proceedings consistent with this order.
