# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0821

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On July 8, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and therefore was disqualified from receiving unemployment insurance benefits effective March 15, 2020 (decision # 63843). Claimant filed a timely request for hearing. On September 3, 2020, ALJ S. Lee conducted a hearing, and on September 11, 2020 issued Order No. 20-UI-153862, affirming decision # 63843. On October 1, 2020, Order No. 20-UI-153862 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 26, 2022, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence claimant's application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 20-UI-153862, mailed to the claimant on September 11, 2020, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 20-UI-153862 at 4. Order No. 20-UI-153862 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before October 1, 2020 to be timely."

**CONCLUSIONS AND REASONS:** The claimant's late application for review of Order No. 20-UI-153862 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or

circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-153862 was due by October 1, 2020. Because the claimant did not file their application for review until July 26, 2022, the application for review was late. Claimant provided a written statement, which was construed as an application for review. However, claimant's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed July 26, 2022 is dismissed. Order No. 20-UI-153862 remains undisturbed.
