

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0826

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On February 8, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able, available, or actively seeking work and was therefore disqualified from receiving unemployment insurance benefits for the weeks including January 9, 2022 through January 29, 2022 (weeks 02-22 through 04-29) and until the reason for the denial had ended (decision # 114044). Claimant filed a timely request for hearing. On March 16, 2022, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for March 30, 2022 at 3:30 PM. On March 30, 2022, claimant failed to appear at the hearing, and ALJ Lucas issued Order No. 22-UI-190144, dismissing claimant's request for hearing for failure to appear. On April 12, 2022, claimant filed a timely request to reopen the hearing. ALJ Kangas considered claimant's request, and on July 13, 2022 issued Order No. 22-UI-198211, denying the request and leaving Order No. 22-UI-190144 undisturbed. On July 28, 2022, claimant filed an application for review of Order No. 22-UI-198211 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-198211 is affirmed.
