EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0832

Affirmed
Ineligible

PROCEDURAL HISTORY: On February 17, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the week of January 23 through 29, 2022 (week 04-22) because she was not available for work that week and until the reason for her denial had ended (decision # 101411). Claimant filed a timely request for hearing on decision # 101411. On June 9, 2022, the Department served notice of an administrative decision concluding that claimant was denied benefits for the week of May 22, 2022 through May 28, 2022 (week 21-22) because she had not registered for work following the Department's rules. Claimant filed a timely request for hearing on the June 9, 2022 administrative decision. On July 19, 2022, ALJ Lucas conducted a hearing on decision # 101411 and the June 9, 2022 administrative decision. On July 21, 2022, ALJ Lucas issued Order No. 22-UI-198783 affirming the June 9, 2022 administrative decision, and on July 27, 2022 issued Order No. 22-UI-199099 modifying decision # 101411 by concluding that was unavailable for work and ineligible for benefits for week 04-22 and the week of May 22 through 28, 2022 (week 21-22). On July 27, 2022, claimant filed an application for review of Orders No. 22-UI-198783 and 22-UI-199099 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-198783 and 22-UI-199099. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0832 and 2022-EAB-0833).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 22-UI-198783 and 22-UI-199099 are affirmed.
