

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0834**

*Order No. 2022-UI-198690 ~ Affirmed ~ Late Request for Hearing Dismissed, Ineligible Weeks 40-21 through 49-21*

*Order No. 2022-UI-198691 ~ Affirmed ~ Overpayment Assessed*

**PROCEDURAL HISTORY:** On December 20, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not able, available, and actively seeking work and was therefore disqualified from receiving unemployment insurance benefits for the weeks including October 3, 2021 through December 11, 2021 (weeks 40-21 through 49-21) and until the reason for the denial had ended (decision # 93221). On January 10, 2022, decision # 93221 became final without claimant having filed a request for hearing. On June 17, 2022, the Department served notice of an administrative decision, based in part on decision # 93221, concluding that claimant received benefits to which she was not entitled and assessing an overpayment of \$2,871 in regular unemployment insurance (regular UI) benefits (decision # 105713). On June 22, 2022, claimant filed a late request for hearing on decision # 93221 and a timely request for hearing on decision # 105713.

On July 19, 2022, ALJ Janzen conducted a consolidated hearing, interpreted in Vietnamese, on decisions # 93221 and 105713. On July 20, 2022, ALJ Janzen issued Order No. 22-UI-198690, dismissing claimant's request for hearing on decision # 93221 as late without a showing of good cause and leaving decision # 93221 undisturbed, and Order No. 22-UI-198691, affirming decision # 105713. On July 27, 2022, claimant filed applications for review of Order Nos. 22-UI-198690 and 22-UI-198691 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-198690 and 22-UI-198691. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0834 and 2022-EAB-0835).

**WRITTEN ARGUMENT:** Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 22-UI-198690 and 22-UI-198691 are affirmed.
