# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0845

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On October 7, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective August 29, 2021 (decision # 155354). On October 27, 2021, decision # 155354 became final without claimant having filed a request for hearing. On November 18, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on February 8, 2022 issued Order No. 22-UI-185864, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 22, 2022. On February 28, 2022, Order No. 22-UI-185864 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On June 7, 2022, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 22-UI-185864. On August 2, 2022, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the appellant questionnaire was late, it would not be considered, another order would not be issued, and Order No. 22-UI-185864 remained in effect. This matter comes before EAB based upon claimant's June 7, 2022 application for review of Order No. 22-UI-185864.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the completed request for hearing form and partial response to the appellant questionnaire claimant submitted with his June 7, 2022 application for review. The additional evidence has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 22-UI-185864, mailed to claimant on February 8, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-185864 at 2. Order No. 22-UI-185864 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than February 28, 2022."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 22-UI-185864 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-185864 was due February 22, 2022. Because claimant did not file his application for review until June 7, 2022, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented him from filing the application for review by the February 22, 2022 deadline. Claimant's partial response to the appellant questionnaire suggests that he received Order No. 22-UI-185864 in February 2022, but does not state why claimant did not file his application for review until several months after its due date. EAB Exhibit 1 at 2. Accordingly, claimant did not show good cause for the late application for review, and his late application for review is dismissed.

**DECISION:** The application for review filed June 7, 2022 is dismissed. Order No. 22-UI-185864 remains undisturbed.
