

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0850

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On November 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of October 31 through November 6, 2021 (week 44-21), and until the reason for the denial had ended. On December 13, 2021, the November 23, 2021 administrative decision became final without claimant having filed a request for hearing. On February 15, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on May 23, 2022 issued Order No. 22-UI-194433, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 6, 2022. On June 13, 2022, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 22-UI-194433 with the Employment Appeals Board (EAB). On August 2, 2022, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's June 13, 2022 application for review of Order No. 22-UI-194433.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

CONCLUSIONS AND REASONS: Order No. 22-UI-194433 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on the November 23, 2021 should be allowed, and if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

On November 23, 2021, the Department mailed the November 23, 2021 administrative decision to claimant at claimant's address of record on file with the Department. The 20-day deadline for claimant to file a timely request for hearing on that decision was December 13, 2021. Claimant did not file a request for hearing on the decision until February 15, 2022. Accordingly, claimant's request for hearing was late.

In their appellant questionnaire response, claimant stated that they actually did request a hearing before the December 13, 2021 deadline. EAB Exhibit 1 at 2. If claimant filed their request for hearing by the deadline, then their request for hearing was timely and they are entitled to a hearing on the merits. However, further inquiry is needed to determine whether claimant requested a hearing by the December 13, 2021 deadline, or if not, otherwise had good cause to file the late request for hearing, and filed the late request for hearing within a reasonable time. On remand, the ALJ should ask questions to confirm when claimant requested a hearing on the November 23, 2021 administrative decision, and if the request was timely filed, why the Department's records showed the request as having been made on February 15, 2022. If the record on remand shows that claimant did not request a hearing until February 15, 2022, the ALJ should also ask questions to develop whether the late request for hearing was the result of a factor beyond claimant's reasonable control or an excusable mistake, and, if so, whether the February 15, 2022 request for hearing was filed within a seven-day "reasonable time."

Order No. 22-UI-194433 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing should be allowed, and if so, the merits of the November 23, 2021 administrative decision.

DECISION: Order No. 22-UI-194433 is set aside, and this matter remanded for further proceedings consistent with this order.
