## **EMPLOYMENT APPEALS BOARD DECISION** **2022-EAB-0856**

---

*Affirmed  
Late Request for Hearing Dismissed  
Overpayment Assessed*

**PROCEDURAL HISTORY:** On January 7, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied regular unemployment insurance benefits for the weeks from December 5, 2021 through January 1, 2022 because he did not actively seek work (decision # 121546). On January 27, 2022, decision # 121546 became final without claimant having filed a request for hearing. On June 24, 2022, the Department served notice of an administrative decision based on decision # 121546 concluding that claimant received \$511 in regular unemployment insurance benefits that he was not eligible to receive and must repay (decision # 115735). On June 30, 2022, claimant filed a late request for hearing on decision # 121546 and a timely request for hearing on decision # 115735. On July 27, 2022, ALJ Roberts conducted a hearing, on July 28, 2022 issued Order No. 22-UI-199192 dismissing claimant's late request for hearing on decision # 121546, and on July 29, 2022 issued Order No. 22-UI-199312 affirming decision # 115735.

On August 1, 2022, claimant filed timely applications for review of Orders No. 22-UI-199192 and 22-UI-199312 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-199192 and 22-UI-199312. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0855 and 2022-EAB-0856).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 22-UI-199192 and 22-UI-199312 are affirmed.
