

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0864

Affirmed
Overpayment and Penalties

PROCEDURAL HISTORY: On December 29, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, assessing an \$18,973 overpayment that claimant was required to repay the Department, a \$5,241.90 monetary penalty, and a 52-week penalty disqualification from future benefits. Claimant filed a timely request for hearing. On March 29, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for April 12, 2022 at 10:45 a.m. On April 12, 2022, claimant failed to appear at the hearing, and on April 18, 2022, ALJ Monroe issued Order No. 22-UI-191512, dismissing claimant's request for hearing due to her failure to appear. On May 5, 2022, claimant filed a request to reopen the hearing.

On June 16, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for June 30, 2022 on whether claimant's request to reopen the hearing should be allowed, and, if so, the merits of the December 29, 2021 administrative decision. On June 30, 2022, ALJ Ramey postponed the hearing and rescheduled for July 15, 2022. On July 15, 2022, ALJ Ramey conducted a hearing interpreted in Cantonese and on July 22, 2022, issued Order No. 22-UI-198905, concluding that good cause for reopening the hearing had been shown, cancelling Order No. 22-UI-191512 and affirming the December 29, 2021 administrative decision. On August 3, 2022, claimant filed an application for review of Order No. 22-UI-198905 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider claimant's written argument when reaching this decision because she did not include a statement declaring that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-198905 is affirmed.
