

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0865

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On April 26, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning March 27, 2022 because they quit working for the employer without good cause (decision # 145447). Claimant filed a timely request for hearing. On May 31, 2022 the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for June 14, 2022. On June 14, 2022, claimant failed to appear at the hearing, and on June 15, 2022 ALJ Mott issued Order No. 22-UI-196136, dismissing claimant's request for hearing due to their failure to appear. On June 22, 2022, claimant filed a timely request to reopen the hearing. ALJ Kangas considered claimant's request, and on July 28, 2022 issued Order No. 22-UI-199183, denying the request. On August 3, 2022, claimant filed a timely application for review of Order No. 22-UI-199183 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Under ORS 657.275(2) and OAR 471-041-0090(1)(b)(A) (May 13, 2019), EAB did not consider claimant's argument because it was not relevant and material to EAB's determination of whether claimant's request to reopen the June 14, 2022 hearing on decision # 145447 should be allowed.

DECISION: Order No. 22-UI-199183 is affirmed.
