

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0868

Affirmed
Late Request for Hearing Allowed
Disqualification

PROCEDURAL HISTORY: On October 29, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective August 29, 2021 (decision # 100218). On November 18, 2021, decision # 100218 became final without claimant having filed a request for hearing. On January 5, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on March 25, 2022 issued Order No. 22-UI-189766, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by April 8, 2022. On April 5, 2022, claimant filed a timely response to the appellant questionnaire. On June 17, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 22-UI-189766 was vacated and that a new hearing would be scheduled to determine whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 100218. On July 25, 2022, ALJ Wardlow conducted a hearing, and on July 28, 2022 issued Order No. 22-UI-199205, allowing claimant's late request for hearing on decision # 100218 and affirming that decision. On August 4, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider claimant's written argument when reaching this decision because he did not include a statement declaring that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-199205 is affirmed.
