## EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0876

Late Application for Review Dismissed

PROCEDURAL HISTORY: On March 23, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was overpaid \$2,874 in Regular Unemployment Insurance Benefits and must repay this amount to the Department, that claimant was overpaid \$9,600 in Federal Pandemic Unemployment Compensation benefits and must repay this amount to the Department, and that claimant was overpaid \$1,510 in Pandemic Emergency Unemployment Compensation benefits and must repay this amount to the Department (decision # 120547). Claimant filed a timely request for hearing. On April 27, 2022 and May 19, 2022, ALJ Janzen conducted a hearing, and on May 20, 2022 issued Order No. 22-UI-194188, affirming decision # 120547. On June 9, 2022, Order No. 22-UI-194188 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On August 8, 2022, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their application for review of Order No. 22-UI-194188, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 22-UI-194188, mailed to the claimant on May 20, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-194188 at 7. Order No. 22-UI-194188 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before June 9, 2022 to be timely."

**CONCLUSIONS AND REASONS:** The claimant's late application for review of Order No. 22-UI-194188 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-194188 was due by June 9, 2022. Because the claimant did not file her application for review until August 8, 2022, the application for review was late. Claimant provided a written statement with her late application for review. In claimant's written statement, claimant asserts that she did not file a timely application for review because "I did not know that I had that right to have this hearings decision reviewed again. I spoke with an attorney yesterday, August 4<sup>th</sup> and was explained that I have a right for further review." EAB Exhibit 1. Claimant's written statement also asserts she had a baby on May 5, 2022, a little over a month before the order became final on June 9, 2022, and states "I have not had the capacity until now to look further and speak with an attorney." EAB Exhibit 1. However, Order No. 22-UI-194188 included an attached form Application for Review with the Employment Appeals Board and stated that claimant could file an appeal of the decision within 20 days. Order No. 22-UI-194188 at 7. While it is understandable that claimant may have wanted to seek the advice of an attorney and having a baby may have made it more challenging for claimant, claimant's written statement did not describe circumstances that constituted good cause for filing the application for review nearly two months after Order No. 22-UI-194188 became final. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed August 8, 2022 is dismissed. Order No. 22-UI-194188 remains undisturbed.
