

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0893

Affirmed
Disqualification

PROCEDURAL HISTORY: On May 19, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged, but not for misconduct, and was therefore not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 154842). The employer filed a timely request for hearing. On July 19, 2022, ALJ Mott conducted a hearing at which claimant did not appear and, on July 27, 2022 issued Amended Order No. 22-UI-199161¹, reversing decision # 154842 by concluding that the employer discharged claimant for misconduct and that claimant was therefore disqualified from receiving benefits effective August 8, 2021. On August 15, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).²

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-199161 is affirmed.

² EAB treated claimant's application for review as an application for review and not as a request to reopen because, per OAR 471-041-0060(5)(b) (effective May 13, 2019), claimant did not include a written statement with the application for review setting forth the reasons claimant missed the July 19, 2022 hearing as required under OAR 471-040-0040(3) (effective February 10, 2012).
