# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0899

## *Affirmed Late Requests for Hearing Dismissed*

**PROCEDURAL HISTORY:** On November 2, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective January 26, 2020 (decision # 84539). On November 23, 2020, decision # 84539 became final without claimant having filed a request for hearing. On May 26, 2021, the Department served notice of an administrative decision based in part on decision # 84539, concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing a \$24,288 overpayment in regular unemployment insurance, Extended Unemployment Compensation (EUC) and Federal Pandemic Unemployment Compensation (FPUC) benefits, a \$1,911 monetary penalty, and a 52 penalty weeks. On June 15, 2021, the May 26, 2021 administrative decision became final without claimant having filed a request for hearing. On March 31, 2022, claimant filed late requests for hearing on decision # 84539 and the May 26, 2021 administrative decision.

On July 21, 2022, ALJ Ramey conducted a hearing on claimant's late request for hearings on decision # 84539 and the May 26, 2021 administrative decision, and on July 29, 2022 issued Orders No. 22-UI-199324 and 22-UI-199323, dismissing claimant's requests for hearing as late without good cause, leaving both administrative decisions undisturbed. On August 17, 2022, claimant filed applications for review of Orders No. 22-UI-199324 and 22-UI-199323 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-199324 and 22-UI-199323. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0899 and 2022-EAB-0898).

**WRITTEN ARGUMENT:** Claimant's August 17, 2022 argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090, EAB considered claimant's August 17, 2022 argument only to the extent it was based on the hearing record. EAB did not consider claimant's August 19, 2022 argument when reaching

this decision because he did not include a statement declaring that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).<sup>1</sup>

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 22-UI-199324 and 22-UI-199323 are affirmed.
