EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0900

Reversed
Request to Reopen Allowed
Merits Hearing Required

PROCEDURAL HISTORY: On June 30, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and therefore was disqualified from receiving unemployment insurance benefits effective June 19, 2022 (decision # 81459). Claimant filed a timely request for hearing. On July 26, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for August 3, 2022 at 1:30 p.m. On August 3, 2022, claimant failed to appear for the hearing. On August 4, 2022, ALJ Monroe issued Order No. 22-UI-199815, dismissing claimant's request for hearing for failure to appear. On August 9, 2022, claimant filed a timely request to reopen the hearing record. ALJ Kangas considered claimant's request, and on August 16, 2022 issued Order No. 22-UI-200660, denying claimant's request to reopen the hearing record and leaving Order No. 22-UI-199815 undisturbed. On August 19, 2022, claimant filed an application for review of Order No. 22-UI-200660 with the Employment Appeals Board (EAB).

FINDINGS OF FACT: (1) On July 26, 2022, OAH served on the parties notice of a hearing scheduled for August 3, 2022 at 1:30 p.m. The notice stated, "At the time of hearing stated, <u>you must call</u> [the hearing phone number]. Using the telephone keypad, enter the access code [provided for the specific hearing]." Exhibit 3 at 1 (emphasis in original).

(2) On August 3, 2022, prior to 1:30 p.m., claimant called the telephone number to access the hearing that was provided on the notice of hearing, but hung up because they were early for the hearing. Claimant called back at 1:30 p.m., but realized they did not have the access code they needed to enter to be admitted to the hearing. Once claimant realized they needed to find the access code, they searched for the notice of hearing to find the access code. They were not able to find the access code and call in again with the access code until 20 minutes after the scheduled time for the hearing. At that time, claimant was too late to be admitted to the hearing.

CONCLUSIONS AND REASONS: Order No. 22-UI-200660 is reversed and this matter remanded for a hearing on the merits of decision # 81459.

ORS 657.270(5) provides that any party who failed to appear at a hearing may request to reopen the hearing, and the request will be allowed if it was filed within 20 days of the date the hearing decision was issued and shows good cause for failing to appear. "Good cause" exists when the requesting party's failure to appear at the hearing arose from an excusable mistake or from factors beyond the party's reasonable control. OAR 471-040-0040(2) (February 10, 2012). The party requesting reopening shall set forth the reason(s) for missing the hearing in a written statement, which the Office of Administrative Hearings (OAH) shall consider in determining whether good cause exists for failing to appear at the hearing. OAR 471-040-0040(3).

Claimant called in to the hearing line prior to the scheduled hearing time, but hung up because they were early for the hearing. Claimant called back into the hearing line at 1:30 p.m., the scheduled time for the hearing, but were unable to attend the hearing because they "overlooked the access code" and therefore "could not enter it when requested." Exhibit 5 at 1. Claimant also stated that they "looked for the hearing notice [to obtain the access code] but it took a while to find," and they were too late to be admitted to the hearing when they called back 20 minutes later. Exhibit 5 at 1. The efforts that claimant described show that claimant made substantial efforts to comply with the instructions on the notice of hearing, but was unable to do so. Therefore, claimant failed to appear at the hearing due to an excusable mistake.

For the above reasons, claimant had good cause to fail to appear at the August 3, 2022 hearing. Claimant's request to reopen the hearing record therefore is allowed, and claimant is entitled to a hearing on the merits of decision # 81459.

DECISION: Order No. 22-UI-200660 is set aside, and this matter remanded for further proceedings consistent with this order.
