

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0905

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On December 6, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the week of September 12 through 18, 2021 because his weekly claim for that week was late (decision # 63731). On December 27, 2021, decision # 63731 became final without claimant having filed a request for hearing. On March 28, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on June 29, 2022 issued 22-UI-197163, dismissing the request as late, subject to claimant's right to renew the request by filing a response to an appellant questionnaire by July 13, 2022. On July 11, 2022, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered the response, and on August 22, 2022 issued Order No. 22-UI-200975, re-dismissing claimant's request for hearing on decision # 63731 as late without good cause. On August 22, 2022, claimant filed an application for review of Order No. 22-UI-200975 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Under ORS 657.275(2) and OAR 471-041-0090(1)(b)(A) (May 13, 2019), EAB did not consider claimant's written argument because it is not relevant and material to EAB's determination of whether claimant's late request for hearing on decision # 63731 should be allowed.

DECISION: Order No. 22-UI-200975 is affirmed.
