EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0935

Late Application for Review Dismissed

PROCEDURAL HISTORY: On January 7, 2022, the Oregon Employment Department (the Department) served Notice of Determination for Pandemic Unemployment Assistance (PUA) benefits concluding that claimant did not file her claims for the weeks from August 26, 2020 through December 26, 2020 before the October 6, 2021 backdating deadline and therefore was denied PUA benefits for those weeks. Claimant filed a timely request for hearing. On February 4, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for February 15, 2022. On February 15, 2022, claimant failed to appear at the hearing, and ALJ Frank issued Order No. 22-UI-186466, dismissing claimant's request for hearing for failing to appear. On March 7, 2022, Order No. 27-UI-186466 became final without claimant having filed a request to reopen the hearing. On April 11, 2022, claimant filed a late request to reopen the hearing. On July 11, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for July 25, 2022 on whether claimant's request to for a reopening should be allowed, and, if so, the merits of the January 7, 2022 PUA determination. On July 25, 2022, ALJ Frank conducted the hearing, and on August 2, 2022, issued Order No. 22-UI-199583, allowing claimant's request for a reopening, and affirming the January 7, 2022 PUA determination. On August 22, 2022, Order No. 22-UI-199583 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On August 24, 2022, claimant filed a late application for review of Order No. 22-UI-199583 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of the claimant's application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: Order No. 22-UI-199583, mailed to claimant on August 2, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-199583 at 6.

Order No. 22-UI-199583 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before August 22, 2022 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-199583 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-199583 was due August 22, 2022. Because claimant did not file her application for review until August 24, 2022, the application for review was late. EAB Exhibit 1. Claimant's application for review included a written statement. However, claimant's written statement did not describe the circumstances that prevented her from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review and her late application for review is dismissed.

DECISION: The application for review filed August 24, 2022 is dismissed. Order No. 22-UI-199583 remains undisturbed.
