**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0938**

---

*Affirmed*  
*Ineligible Weeks 5-21 through 26-21*

**PROCEDURAL HISTORY:** On July, 22, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks from January 31, 2021 through July 3, 2021 (weeks 5-21 through 26-21) and therefore was denied benefits for those weeks (decision # 100625). Claimant filed a timely request for hearing. On August 10, 2022, ALJ Smith conducted a hearing, and on August 18, 2022 issued Order No. 22-UI-200847, affirming decision # 100625. On September 7, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB considered claimant's written argument in reaching this decision. Claimant's argument, as well as the record under review, presents evidence that claimant's failure to file timely claims for benefits for each of the weeks at issue was caused, at least in part, by the Department's inability to handle the volume of requests it received in a time-sensitive manner. Claimant attempted numerous times to contact the Department to request assistance in resetting his personal identification number (PIN) in order to make continued claims. Had the Department been able to timely respond to claimant's requests, claimant may have been able to reset his PIN and timely claim some or all of the weeks at issue. While the Department has promulgated some temporary rules and other policies to address the COVID-19 pandemic and the unprecedented demands it placed on the Department, no good cause exceptions were made to the administrative rules in regards to the timely filing of the continued claims at issue. Despite the inequity of such a result, EAB is nevertheless bound by the Department's administrative rules, and has no authority to override them for the sake of equity.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-200847 is affirmed.
