EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0944

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 22, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was unable to work from April 3 through 16, 2022 and was therefore denied benefits for that period and until the reason for the denial had ended (decision # 105359). Claimant filed a timely request for hearing. On May 19, 2022, ALJ Monroe conducted a hearing, and on May 31, 2022 issued Order No. 22-UI-194913, modifying decision # 105359 by concluding that claimant was unable to work during the weeks from April 3 through May 14, 2022 (weeks 14-22 through 19-22), and therefore was ineligible for benefits for those weeks. On June 20, 2022, Order No. 22-UI-194913 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On September 8, 2022, claimant filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant included with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 22-UI-194913, mailed to claimant on May 31, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-194913 at 3. Order No. 22-UI-194913 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before June 20, 2022 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-194913 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-194913 was due June 20, 2022. Because claimant did not file their application for review until September 8, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, Claimant's written statement did not describe the circumstances that prevented them from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and September 8, 2022's late application for review is dismissed.

DECISION: The application for review filed September 8, 2022 is dismissed. Order No. 22-UI-194913 remains undisturbed.
