EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0952

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 11, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective December 29, 2019 (decision # 95044). On October 1, 2020, decision # 95044 became final without claimant having filed a timely request for hearing. On March 22, 2022 claimant filed a late request for hearing on decision # 95044. ALJ Kangas considered claimant's request, and on June 22, 2022, issued Order No. 22-UI-196612, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 6, 2022. On July 12, 2022, Order No. 22-UI-196612 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On September 9, 2022, claimant filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, which claimant submitted to EAB with additional documents, which has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 22-UI-196612, mailed to the claimant on June 22, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-196612 at 2. Order No. 22-UI-196612 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than July 12, 2022."

CONCLUSIONS AND REASONS: The claimant's late application for review of Order No. 22-UI-196612 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-196612 was due by July 12, 2022. Because the claimant did not file their application for review until September 9, 2022, the application for review was late. Claimant provided documents with their application for review. However, claimant's documents do not describe the circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed September 9, 2022 is dismissed. Order No. 22-UI-196612 remains undisturbed.
