

**EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0958**

*Affirmed
Disqualification*

PROCEDURAL HISTORY: On November 5, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer with good cause due to entering into an approved Trade Act training and was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 104302). The employer filed a timely request for hearing. On August 25, 2022, ALJ Mott conducted a hearing, and on August 29, 2022 issued Order No. 22-UI-201528, reversing decision # 104302 by concluding that claimant quit without good cause and was disqualified from receiving benefits effective September 26, 2021. On September 12, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

In claimant's argument, claimant stated, "I respectfully request to be released of repayment of unemployment benefits." Written Argument at 2. Whether or not claimant is liable for an overpayment of any benefits received is beyond the scope of this case and therefore not before EAB. However, nothing in this decision or the underlying hearing order should be interpreted as preventing claimant from appealing any overpayment decision issued in connection with the work separation in this case. Claimant is free to appeal any overpayment decision the Department issues to her. Claimant is also free to apply for a waiver of any overpayment assessed against her, and if the Department denies such a waiver request, appeal the overpayment waiver denial. Both of these avenues are available for claimant to pursue, and this decision does not interfere with claimant's ability to pursue them.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-201528 is affirmed.
