

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0961**

*Affirmed*  
*Late Request to Reopen Dismissed*

**PROCEDURAL HISTORY:** On February 19, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective November 15, 2020 (decision # 141232). Claimant filed a timely request for hearing. On March 9, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for March 23, 2021. On March 23, 2021, claimant failed to appear at the hearing, and on March 24, 2021, ALJ Scott issued Order No. 21-UI-163338, dismissing claimant's request for hearing due to her failure to appear. On April 13, 2021, Order No. 21-UI-163338 became final without claimant having filed a request to reopen the hearing. On August 5, 2022, claimant filed a late request to reopen the hearing. ALJ Kangas considered the request, and on August 29, 2022 issued Order No. 22-UI-201544, dismissing the request as late without good cause, leaving Order No. 21-UI-163338 undisturbed. On September 14, 2022, claimant filed an application for review of Order No. 22-UI-201544 with the Employment Appeals Board (EAB).

**EVIDENTIARY MATTER:** With her application for review, claimant submitted a document from the employer relevant to the merits of decision # 141232. However, EAB did not consider the document because it is not relevant and material to the only issue before EAB, whether claimant's late request to reopen the March 23, 2021 hearing on decision # 141232 should be allowed. *See* ORS 657.275(2); OAR 471-041-0090(1)(b)(A) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-201544 is affirmed.
