# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0963

Late Applications for Review Dismissed Without Prejudice

**PROCEDURAL HISTORY:** On April 22, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed a late claim for unemployment insurance benefits for the week of February 6, 2022 through February 12, 2022 and therefore was denied benefits for that week (decision # 92159). Also on April 22, 2022, the Department served notice of an administrative decision concluding that claimant filed a late claim for unemployment insurance benefits for the week of March 27, 2022 through April 2, 2022 and therefore was denied benefits for the week of March 27, 2022 through April 2, 2022 and therefore was denied benefits for that week (decision # 92717). Claimant filed timely requests for hearing on decisions # 92159 and 92717. On June 14, 2022, ALJ Blam-Linville conducted a hearing and issued Order Nos. 22-UI-196076 and 22-UI-196075, affirming decisions # 92159 and 92717. On July 5, 2022, Order Nos. 22-UI-196076 and 22-UI-196075 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On September 6, 2022, claimant filed late applications for review of Order Nos. 22-UI-196076 and 22-UI-196076 and 22-UI-196075 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 22-UI-196076 and 22-UI-196075. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0962 and 2022-EAB-0963).

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their applications for review of Order Nos. 22-UI-196076 and 22-UI-196075, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDINGS OF FACT:** (1) Order No. 22-UI-196076, mailed to claimant on June 14, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-22-UI-196076 at 3. Order No. 22-UI-196076 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 5, 2022 to be timely."

(2) Order No. 22-UI-196075, mailed to claimant on June 14, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-196075 at 3. Order No. 22-UI-196075 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 5, 2022 to be timely."

CONCLUSIONS AND REASONS: The applications for review are dismissed without prejudice.

On September 6, 2022, the appellant filed applications for review of Order Nos. 22-UI-196076 and 22-UI-196075 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the applications for review to be filed no later than July 5, 2022. The appellant's applications for review are therefore late, and the applications for review are dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late applications for review within a reasonable time, the appellant may request that EAB reconsider these decisions under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is October 11, 2022, making the deadline October 31, 2022<sup>1</sup>, to file the request for reconsideration, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, how the reason(s) affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 4. Send EAB a fax at 503-378-2129.

**DECISION:** The applications for review filed September 6, 2022 are dismissed. Order Nos. 22-UI-196076 and 22-UI-196075 remain undisturbed.
