# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0966

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On March 23, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from unemployment insurance benefits effective February 27, 2022 (decision # 82910). Claimant filed a timely request for hearing. On April 21, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for May 3, 2022. On May 3, 2022, claimant failed to appear at the hearing, and on May 4, 2022 ALJ Wardlow issued Order No. 22-UI-192846, dismissing claimant's request for hearing due to his failure to appear. On May 12, 2022, claimant filed a request to reopen the hearing. OAH considered the request and on August 2, 2022, served notice of a hearing scheduled for August 15, 2022. On August 15, 2022, ALJ Wardlow conducted the hearing, and on August 17, 2022 issued Order No. 22-UI-200749, allowing claimant's request to reopen the May 3, 2022 hearing and concluding that the employer discharged claimant but not for misconduct, and that claimant therefore was not disqualified from unemployment insurance benefits based on the work separation. On September 6, 2022, Order No. 22-UI-200749 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On September 16, 2022, the employer filed a late application for review with EAB.

**FINDINGS OF FACT:** (1) Order No. 22-UI-200749, mailed to the employer on August 17, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-200749 at 6. Order No. 22-UI-200749 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before September 6, 2022 to be timely."

**CONCLUSIONS AND REASONS:** The employer's application for review of Order No. 22-UI-200749 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or

circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-200749 was due by September 6, 2022. Because the employer did not file their application for review until September 16, 2022, the application for review was late. The employer's application for review did not include a written statement describing circumstances that prevented them from filing the application for review by the September 6, 2022 deadline. Accordingly, the employer did not show good cause for the late application for review, and the employer's late application for review is dismissed.

**DECISION:** The application for review filed September 16, 2022 is dismissed. Order No. 22-UI-200749 remains undisturbed.
