

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0969

Application for Review Dismissed
No Justiciable Controversy

PROCEDURAL HISTORY AND FINDINGS OF FACT: On April 1, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and claimant was disqualified from receiving unemployment insurance benefits effective March 13, 2022 (decision # 95520). Claimant filed a timely request for hearing. On September 9, 2022, ALJ Clemons conducted a hearing at which the employer did not appear, and on September 13, 2022 issued Order No. 22-UI-202539, reversing decision # 95520 by concluding that the employer discharged claimant, but not for misconduct, and claimant was not disqualified from receiving benefits based on the work separation. On September 17, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 22-UI-202539 presents no justiciable controversy and is dismissed.

On September 17, 2022, claimant filed with EAB an application for review of Order No. 22-UI-202539, an order that allowed claimant benefits based on the work separation. Claimant did not assign error to any portion of that order, did not request reversal of any portion of that order, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review of Order No. 22-UI-202539. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 22-UI-202539 is dismissed.

DECISION: The application for review filed September 17, 2022 is dismissed. Order No. 22-UI-202539 remains undisturbed.
