

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0975

Affirmed
Late Request to Reopen Dismissed

PROCEDURAL HISTORY: On June 29, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective May 9, 2021 (decision # 92611). Claimant filed a timely request for hearing. On September 8, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for September 21, 2021. On September 21, 2021, claimant failed to appear at the hearing, and ALJ Wardlow issued Order No. 21-UI-175282, dismissing claimant's request for hearing for failure to appear. On October 11, 2021, Order No. 21-UI-175282 became final without claimant having filed a request to reopen the hearing. On August 15, 2022, claimant filed a late request to reopen the hearing. ALJ Kangas considered the request, and on September 12, 2022 issued Order No. 22-UI-202476, dismissing the request as late without good cause, leaving Order No. 21-UI-175282 undisturbed. On September 19, 2022, claimant filed an application for review of Order No. 22-UI-202476 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: The written argument claimant submitted with their application for review contained new information regarding claimant's request to reopen the September 21, 2021 hearing. EAB did not consider the new information because claimant failed to show that factors or circumstances beyond their reasonable control prevented them from offering the information into the hearing record with their request to reopen, as required under OAR 471-040-0040(3) and OAR 471-040-0041(4) (February 10, 2012). *See* ORS 657.275(2); OAR 471-041-0090(1)(b)(B) (May 13, 2019). EAB did not consider the written argument claimant submitted on October 17, 2022 because it is not relevant and material to the only issue before EAB, whether claimant's late request to reopen the September 21, 2021 hearing should be allowed. *See* ORS 657.275(2); OAR 471-041-0090(1)(b)(A) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-202476 is affirmed.
