

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0992

Affirmed
Not Monetarily Qualified for Benefits

PROCEDURAL HISTORY: On May 28, 2020, the Oregon Employment Department (the Department) served notice of a Wage and Potential Benefit Report concluding that claimant did not monetarily qualify for unemployment insurance benefits because he did not have sufficient subject wages or hours worked during his base year. On June 7, 2020, the May 28, 2020 Wage and Potential Benefit Report decision became final without claimant having filed a request for hearing. On November 11, 2021, claimant filed a late request for hearing. ALJ Kangas considered the request, and on January 26, 2022 issued order 22-UI-184893, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by February 9, 2022. On February 4, 2022, claimant filed a timely response to the appellant questionnaire. On April 13, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 22-UI-184893 was vacated and that a new hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of the May 28, 2020 Wage and Potential Benefit Report decision. On September 9, 2022, ALJ Scott, conducted a hearing, and on September 14, 2022 issued Order No. 22-UI-202656, allowing claimant's late request for hearing, and affirming the May 28, 2020 Wage and Potential Benefit Report decision. On September 28, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-202656 is affirmed.
