EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0996

Late Application for Review of Order No. 21-UI-176265 Dismissed

PROCEDURAL HISTORY: On December 29, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning February 23, 2020 because she quit working for an employer without good cause (decision # 100215). On January 19, 2021, decision # 100215 became final without claimant having filed a request for hearing. On March 24, 2021, the Department served notice of an administrative decision concluding that claimant was overpaid \$14,349 in Extended and Federal Pandemic Unemployment Compensation benefits that she must repay the Department (decision # 105527). On April 13, 2021, decision # 105527 became final without claimant having filed a request for hearing.

On June 10, 2021, claimant filed a late request for hearing on decisions # 100215 and 105527. ALJ Kangas considered claimant's request, an on July 9, 2021 issued Orders No. 21-UI-170083 and 21-UI-170082 dismissing the request for hearings on decisions # 100215 and 105527 as late without a showing of good cause, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 23, 2021. On July 19, 2021, claimant filed a timely response to the appellant questionnaire. The Office of Administrative Hearings (OAH) considered claimant's response, and on October 4, 2021, mailed a letter stating that Order No. 21-UI-170083 was cancelled and vacated, and that a hearing would be scheduled to address whether claimant's late request for hearing on decision # 100215 should be allowed and, if so, the merits of the decision.

Also on October 4, 2021, ALJ S. Lee issued Order No. 21-UI-176265, re-dismissing claimant's late request for hearing on decision # 105527 as late without a showing of good cause, leaving decision # 105527 undisturbed. On October 25, 2021, Order No. 21-UI-176265 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On September 29, 2022, claimant filed an application for review of Order No. 21-UI-176265 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence the written statement claimant included with her application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such

objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: (1) Order No. 21-UI-176265, mailed to claimant on October 4, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-176265 at 3. Order No. 21-UI-176265 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before October 25, 2021 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-176265 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-176265 was due October 25, 2021. Because claimant did not file their application for review until September 29, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented her from filing the application for review of Order No. 21-UI-176265 on time. Instead, it stated that claimant never received notice of the hearing regarding decision # 100215 referenced in OAH's October 4, 2021 letter stating that Order No. 21-UI-170083 was cancelled and vacated. EAB Exhibit 1. It also suggested that claimant disagreed with an administrative issued by the Department denying claimant's request for a waiver of the overpayment assessed in decision # 105527 (decision # 142141). EAB Exhibit 1. Because claimant's written statement did not describe the circumstances that prevented her from filing the application for review of Order No. 21-UI-176265 on time, she did not show good cause for the late application for review of Order No. 21-UI-176265, and her late application for review of Order No. 21-UI-176265 is dismissed.

DECISION: The application for review of Order No. 21-UI-176265 filed September 29, 2022 is dismissed. Order No. 21-UI-176265 remains undisturbed.
