EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1013

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On December 29, 2020, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. On January 19, 2021, the December 29, 2020 PUA determination became final without claimant having filed a request for hearing. On March 19, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on July 1, 2022 issued Order No. 22-UI-197413, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 15, 2022. On July 18, 2022, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 22-UI-197413 with the Employment Appeals Board (EAB). On October 3, 2022, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's July 18, 2022 application for review of Order No. 22-UI-197413.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's July 18, 2022 response to the appellant questionnaire, including a statement submitted with the response, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) On December 29, 2020, the Department mailed the December 29, 2020 PUA determination to claimant's address on file with the Department. The December 29, 2020 PUA determination stated, "You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received by January 19, 2021." Exhibit 1 at 4.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist. Under OAR 471-040-0010(1)(b)(B), "good cause" does not include not understanding the implications of a decision or notice when it is received.

The request for hearing on the December 29, 2020 PUA determination was due by January 19, 2021 to be timely. Because claimant did not file their request for hearing until March 19, 2022, the request was late. Claimant's response to the appellant questionnaire indicated that claimant received the "administrative decision" on July 6, 2022. EAB Exhibit 1 at 1. However, because claimant did not otherwise state in their appellant questionnaire that they did not receive the PUA determination after it was mailed to them on December 29, 2020, it is presumed that claimant meant that they received Order No. 22-UI-197413 (mailed July 1, 2022) on July 6, 2022, and not the December 29, 2020 PUA determination.

Claimant's responses on the appellant questionnaire did not show that they were delayed in filing the request for hearing due to factors beyond their control. Claimant asserted that they did not request a hearing by January 19, 2021 due to the "confusion" associated with the pandemic and because the Department told them they qualified for PUA benefits. EAB Exhibit 1 at 2, 3. However, the December 29, 2020 decision stated that claimant was not entitled to PUA benefits, and that claimant had the right to appeal the decision "if [they] do not believe it is correct." Claimant's assumption that the PUA determination would not affect their entitlement to PUA benefits shows that they did not understand the implications of the December 29, 2020 PUA determination. Under OAR 471-040-0010(1)(b)(B), not understanding the implications of a decision when it is received does not constitute good cause for filing a late request for hearing.

In addition, although claimant's failure to file a timely request for hearing was likely the result of a mistake on claimant's part, claimant did not show that it was an "excusable mistake" within the meaning of the administrative rules because it did not, for example, raise a due process issue, and was not the result of inadequate notice, reasonable reliance on another, or the inability to follow directions despite substantial efforts to comply. Therefore, claimant's late request for hearing on the December 29, 2020 PUA determination is subject to dismissal under ORS 657.875 and OAR 471-040-0010.

DECISION: Order No. 22-UI-197413 is affirmed.
