EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1015

Affirmed
Request for Hearing Dismissed

PROCEDURAL HISTORY: On June 24, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant, not for misconduct, and that claimant was not disqualified from receiving benefits based on the work separation (decision # 70355). The employer filed a timely request for hearing. On July 11, 2022, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for July 26, 2022. On July 26, 2022, ALJ Buckley conducted the hearing at which employer appeared and claimant failed to appear and issued Order No. 22-UI-199003, reversing decision # 70355 by concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective May 17, 2020. On August 5, 2022, claimant filed a timely request to reopen the hearing.

On August 10, 2022, OAH served notice of a hearing scheduled for September 6, 2022 to determine whether claimant's request to reopen the hearing should be allowed and, if so, the merits of decision # 70355. On September 1, 2022, the Department issued an administrative decision concluding that the Department had no jurisdiction to issue decision # 70355, which therefore was cancelled, making Order No. Order No. 22-UI-199003 void by operation of law. On September 6 and 7, 2022, ALJ Buckley conducted a hearing during which the ALJ concluded that claimant's request to reopen should be allowed. On September 7, 2022, OAH served notice of a hearing scheduled for September 14, 2022 to address whether claimant should be disqualified from receiving benefits based on their work separation from the employer.

On September 13, 2022, OAH mailed a letter to the parties stating that because decision # 70355 was cancelled, Order No. 22-UI-199003 was voided, and OAH would take no further action on the matter. On September 14, 2022, ALJ Buckley issued Order No. 22-UI-202649, dismissing the employer's request for hearing on decision # 70355 based on the Department's cancellation of decision # 70355. On October 3, 2022, the employer filed an application for review of Order No. 22-UI-202649 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-202649 is affirmed.
