EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1018

Affirmed Overpayment Assessed

PROCEDURAL HISTORY: On May 27, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$5,396 in regular unemployment insurance (regular UI) benefits, \$900 in Federal Pandemic Unemployment Assistance (FPUC) benefits and \$1,200 in Lost Wages Assistance (LWA) benefits to which she was not entitled and must to repay to the Department. Claimant filed a timely request for hearing. On September 14, 2022, ALJ Janzen conducted a hearing, and on September 16, 2022 issued Order No. 22-UI-202924, affirming the May 27, 2021 administrative decision. On October 5, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider claimant's written argument filed with her application for review because she did not include a statement declaring that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing as required by OAR 471-041-0090. Claimant's argument dated November 1, 2022 contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090, EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's November 1, 2022 argument to the extent it was based on the record.

In her November 1, 2022 written argument, claimant noted that the order under review misstated claimant's pay raise during the period at issue as resulting in an hourly wage of \$23.63, rather than \$20.63. Claimant's November 1, 2022 Written Argument at 1; Order No. 22-UI-202924 at 2. While claimant's assertion is correct, the error did not affect the result reached by the order under review. The record shows that the May 27, 2021 administrative decision calculated claimant's earnings after her pay raise in July 2020 based on her having been paid an hourly rate of \$20.63, which in turn was based on information that the employer had provided to the Department. *See* Exhibit 1 at 4, 6–7. The order under

review reached the same conclusion regarding the amount of claimant's overpayment. Order No. 22-UI-202924 at 7. Thus, it is clear that the error noted in the order under review was merely a typographical error, and did not factor into the calculation upon which its conclusion was based.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-202924 is affirmed.
