

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-1053

Affirmed
Disqualified

PROCEDURAL HISTORY: On July 21, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision that allowed claimant unemployment insurance benefits, concluding that the employer discharged her, but not for misconduct (decision # 151455). The employer filed a timely request for hearing. On October 3, 2022, ALJ Enyinnaya conducted a hearing, and on October 6, 2022 issued Order No. 22-UI-204532, reversing decision # 151455 by concluding that claimant was discharged for misconduct and disqualified from receiving benefits effective October 31, 2021.¹ On October 18, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider claimant's written argument when reaching this decision because she did not include a statement declaring that she provided a copy of her argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-204532 is affirmed.

¹ The "Order" portion of Order No. 22-UI-204532 erroneously stated that claimant's disqualification was effective October 10, 2021. Order No. 22-UI-204532 at 5. However, Order No. 22-UI-204532 found that the employer discharged claimant on October 31, 2021. Order No. 22-UI-204532 at 2 ¶ 13. This finding is accurate and reflects the testimony of the parties. *See* Transcript at 5, 12, 17-18. Therefore, the reference to October 10, 2021 is presumed to be a typographical error, and Order No. 22-UI-204532 is construed as establishing claimant's disqualification date as effective October 31, 2021.
