EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1065

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 28, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work from March 15 through June 20, 2020 and therefore was denied benefits for that period and until the reason for her denial had ended (decision # 112308). Also on December 28, 2020, the Department served notice of an administrative decision concluding that claimant was not available for work from June 21 through July 18, 2020 and therefore was denied benefits for that period and until the reason for her denial had ended (decision # 114740). On January 19, 2021, decisions # 112308 and 114740 became final without claimant having filed a request for hearing on either decision. On April 27, 2022, the Department served notice of two administrative decisions based on decisions # 112308 and 114740, concluding that claimant was overpaid a total of \$14,348 in regular unemployment insurance (UI) and Federal Pandemic Unemployment Compensation (FPUC) benefits that she must repay the Department (decisions # 123816 and 125325). On May 17, 2022, decisions # 123816 and 125325 became final without claimant having filed a request for hearing on either decision.

On May 23, 2022, claimant filed a late request for hearing on decisions # 112308, 114740, 123816 and 125325. ALJ Kangas considered claimant's request, and on September 6, 2022 issued Orders No. 22-UI-202099, 22-UI-202100, 22-UI-202102 and 22-UI-202105, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 20, 2022. On September 26, 2022, Orders No. 22-UI-202099, 22-UI-202100, 22-UI-202102 and 22-UI-202105 became final without claimant having responded to the appellant questionnaire or filed an application for review with the Employment Appeals Board (EAB). On October 13, 2022 claimant filed a late response to the appellant questionnaire and a late application for review of Orders No. 22-UI-202099, 22-UI-202100, 22-UI-202102 and 22-UI-202105 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-202099, 22-UI-202100, 22-UI-202102 and 22-UI-202105. For case-tracking purposes, this decision is being issued in quadruplicate (EAB Decisions 2022-EAB-1063, 2022-EAB-1064, 2022-EAB-1065 and 2022-EAB-1066).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the appellant questionnaire response claimant included with her application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: (1) Orders No. 22-UI-202099, 22-UI-202100, 22-UI-202102 and 22-UI-202105, mailed to claimant on September 6, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Orders No. 22-UI-202099, 22-UI-202100, 22-UI-202102 and 22-UI-202105 at 2. Orders No. 22-UI-202099, 22-UI-202100, 22-UI-202102 and 22-UI-202105 also stated on their Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than September 26, 2022."

CONCLUSIONS AND REASONS: Claimant's late application for review of Orders No. 22-UI-202099, 22-UI-202100, 22-UI-202102 and 22-UI-202105 are dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Orders No. 22-UI-202099, 22-UI-202100, 22-UI-202102 and 22-UI-202105 was due September 26, 2022. Because claimant did not file her application for review until October 13, 2022, the application for review was late. The only written statement claimant included with her application for review was her response to the appellant questionnaire, which did not describe circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for her late application for review, and the late application for review is dismissed.

DECISION: The application for review filed October 13, 2022 is dismissed. Orders No. 22-UI-202099, 22-UI-202100, 22-UI-202102 and 22-UI-202105 remain undisturbed.
