

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-1071

Late Application for Review Dismissed

PROCEDURAL HISTORY: On August 21, 2018, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer for good cause and was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 90429). The employer filed a timely request for hearing. On September 25, 2018, ALJ Davis conducted a hearing, and on September 28, 2018 issued Order No. 18-UI-117408, reversing decision # 90429 by concluding that claimant quit working for the employer without good cause and therefore was disqualified from receiving benefits effective July 22, 2018. On October 18, 2018, Order No. 18-UI-117408 became final without claimant having filed an application for review with the Employment Appeals Board (EAB).

On March 28, 2022, claimant filed a late application for review of Order No. 18-UI-117408, which was mistakenly construed by the Office of Administrative Hearings (OAH) as a late request for hearing. ALJ Kangas considered the request, and on June 29, 2022, issued Order No. 22-UI-197180, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 13, 2022. On October 25, 2022, OAH mailed claimant a letter stating that OAH had vacated Order No. 22-UI-197180 because Order No. 22-UI-197180 was issued in error as a hearing was previously held on the merits of decision # 90429. This matter comes before EAB based on claimant's late application for review of Order No. 18-UI-117408.

FINDING OF FACT: (1) Order No. 18-UI-117408, mailed to claimant on September 28, 2018, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 18-UI-117408 at 3. Order No. 18-UI-117408, also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before October 18, 2018 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-197180 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-197180 was due on October 18, 2018. Because claimant did not file their application for review until March 28, 2022, the application for review was late. Claimant’s application for review did not include a written statement describing the circumstances that prevented them from filing the application for review by the October 18, 2018 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed March 28, 2022 is dismissed. Order No. 18-UI-117408 remains undisturbed.
