

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-1075

Affirmed
Eligible Weeks 31-22 to 32-22
Disqualification Effective Week 33-22

PROCEDURAL HISTORY: On August 22, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant, not for misconduct, within 15 days of claimant quitting without good cause, disqualifying claimant from receiving benefits effective August 14, 2022 (decision # 82033). Claimant filed a timely request for hearing. On October 5, 2022, ALJ D. Lee conducted a hearing, and on October 11, 2022, issued Order No. 22-UI-204800, affirming decision # 82033. On October 24, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, but showed that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing as required by OAR 471-041-0090. However, this additional information is not admissible because it is irrelevant and immaterial. OAR 471-040-0025(5) provides in pertinent part: "Irrelevant, immaterial, or unduly repetitious evidence shall be excluded. . ."

Claimant contends that his submission supports his argument that he left work with good cause due to compelling family reasons. A "compelling family reason" as defined under OAR 471-030-0038(1)(e)(B) includes, "The illness or disability of a member of the individual's immediate family necessitates care by another and the individual's employer does not accommodate the employee's request for time off."

However, the record does not show that claimant quit because he requested time off from the employer to care for his mother and that such request was denied, as required by the rule. Therefore, the severity of claimant's mother's condition is not relevant or material to the determination of whether claimant quit for a compelling family reason.

Further, changes to claimant's mother's condition or treatment after claimant quit have no bearing on whether claimant's reason for quitting was of "such gravity that [he] had no reasonable alternative but to leave work." OAR 471-030-0038(4) (September 22, 2020). The order under review found that claimant voluntarily quit because he was dissatisfied with the employer's refusal to increase his pay, which was

not a situation of sufficient gravity to justify quitting. Order No. 22-UI-204800 at 4. The record supports this conclusion. Changes in circumstance that occur after claimant has already quit for other reasons cannot constitute good cause for having left work, and are therefore not relevant or material to the good cause analysis. Accordingly, the additional information submitted by claimant is excluded. However, claimant's written argument was considered to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-204800 is affirmed.
