EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1093

Late Application for Review Dismissed

PROCEDURAL HISTORY: On August 17, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and therefore was disqualified from receiving unemployment insurance benefits effective July 24, 2022 (decision # 120958). Claimant filed a timely request for hearing. On September 19, 2022, ALJ Goodrich conducted a hearing that was continued on September 23, 2022, and on September 30, 2022, issued Order No. 22-UI-204020, reversing decision # 120958 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On October 20, 2022, Order No. 22-UI-204020 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On October 27, 2022, the employer filed a late application for review of Order No. 22-UI-204020 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of the employer's written statement and additional documents enclosed with their application for review, and has been marked as EAB Exhibit 1. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 22-UI-204020, mailed to the employer on September 30, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-204020 at 6. Order No. 22-UI-204020 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before October 20, 2022 to be timely."

CONCLUSIONS AND REASONS: The employer's late application for review of Order No. 22-UI-204020 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-204020 was due by October 20, 2022. Because the employer did not file their application for review until October 27, 2022, the application for review was late. The employer provided a written statement with the application for review. However, the employer's written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, the employer did not show good cause for the late application for review, and the employer's late application for review is dismissed.

DECISION: The application for review filed October 27, 2022 is dismissed. Order No. 22-UI-204020 remains undisturbed.
