

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-1099

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 3, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective July 18, 2021 (decision # 150656). Claimant filed a timely request for hearing. On September 10, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for September 24, 2021 at 8:15 a.m. On or about September 21, 2021, claimant contacted OAH and requested to withdraw their request for hearing. On September 29, 2021, ALJ Ramey issued Order No. 21-UI-175902, dismissing claimant's request for hearing based on their withdrawal request. On October 19, 2021, Order No. 21-UI-175902 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On August 25, 2022, claimant filed a late application for review of Order No. 21-UI-175902 by EAB.¹

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's late application for review and attached statement, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: (1) Order No. 21-UI-175902, mailed to claimant on September 29, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-175902 at 1.

¹ On August 25, 2022, claimant submitted a web form on which they indicated that they sought to have the case "reopened." EAB Exhibit 1 at 1. Under OAR 471-040-0040 (February 12, 2012), an administrative law judge may, under certain circumstances, reopen a hearing record when the party requesting the reopening failed to appear at the hearing. In this case, claimant did not fail to appear at the hearing because, as a result of their withdrawal request, no hearing took place. Therefore, claimant's request to "reopen" has been construed as an application for review of Order No. 21-UI-175902 by EAB.

Order No. 21-UI-175902 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before October 19, 2021 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 21-UI-175902 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-175902 was due by October 19, 2021. Because claimant did not file their application for review until August 25, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant’s written statement did not describe the circumstances that prevented them from filing the application for review on time. Accordingly, Claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed August 25, 2022 is dismissed. Order No. 21-UI-175902 remains undisturbed.
