EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1109

Late Application for Review Dismissed

PROCEDURAL HISTORY: On May 17, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the weeks including April 24, 2022 through May 21, 2022 (weeks 17-22 through 20-22) and until the reason for the denial had ended. On June 6, 2022, the May 17, 2022 administrative decision became final without claimant having filed a request for hearing. On June 24, 2022, claimant filed a late request for hearing on the May 17, 2022 administrative decision. ALJ Kangas considered claimant's request, and on October 12, 2022 issued Order No. 22-UI-204880, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 26, 2022. On November 1, 2022, Order No. 22-UI-204880 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On November 4, 2022, claimant filed a late application for review of Order No. 22-UI-204880 with EAB.

FINDING OF FACT: (1) Order No. 22-UI-204880, mailed to claimant on October 12, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-204880 at 2. Order No. 22-UI-204880 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 1, 2022."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 22-UI-204880 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it

includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-204880 was due by November 1, 2022. Because claimant did not file their application for review until November 4, 2022, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented them from filing the application for review by the November 1, 2022 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed November 4, 2022 is dismissed. Order No. 22-UI-204880 remains undisturbed.
