# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-1116

Late Application for Review Allowed Affirmed ~ Ineligible Weeks 06-20 through 49-20 Eligible Weeks 50-20 through 35-21

**PROCEDURAL HISTORY:** On April 14, 2022, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was ineligible to receive PUA benefits for weeks prior to December 6, 2020. Claimant filed a timely request for hearing. On June 13, 2022, ALJ Scott conducted a hearing, and on June 15, 2022 issued Order No. 22-UI-196216, modifying the April 14, 2022 administrative decision by concluding that claimant was ineligible to receive PUA benefits for the weeks including February 2, 2020 through December 5, 2020 (weeks 06-20 through 49-20) but was eligible to receive PUA benefits for the weeks including December 6, 2020 through September 4, 2021 (weeks 50-20 through 35-21). On July 5, 2022, Order No. 22-UI-196216 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On November 7, 2022, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of a statement enclosed with claimant's application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

Along with the statement enclosed with her application for review, claimant also included attached documents relating to the merits of the April 14, 2022 administrative decision. On November 28, 2022, claimant submitted a written argument which included the same statement that was enclosed with her application for review, as well as the same and additional attached documents. Those attached documents contained new information that was not part of the hearing record and that was not relevant or material to EAB's determination. Under ORS 657.275(2) and OAR 471-041-0090, and excluding the information contained within claimant's statement itself, EAB considered only information received into

evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

**FINDINGS OF FACT:** (1) Order No. 22-UI-196216, mailed to claimant on June 15, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-196216 at 3. Order No. 22-UI-196216 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 5, 2022 to be timely."

**CONCLUSIONS AND REASONS:** Claimant had good cause to file the late application for review of Order No. 2022-UI-196216.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-196216 was due by July 5, 2022. Because claimant did not file her application for review until November 7, 2022, the application for review was late. On the statement enclosed with her application for review, claimant stated that she did not receive her "denial letter until 2 days ago." EAB Exhibit 1 at 1. Because claimant did not receive a copy of the order under review until well after the timely filing deadline had passed, claimant filed the late application for review due to circumstances beyond her control. Those factors ceased when she received the order under review on November 5, 2022. As claimant filed the application for review two days later, she did so within a reasonable time after the circumstances ceased. Therefore, claimant had good cause to file the late application for review, and her late application for review is allowed.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Claimant's late application for review of Order No. 22-UI-196216 is allowed. Order No. 22-UI-196216 is affirmed.
